
SUPPLIER PRICE INDEX

FOURTH QUARTER 2019

The DISCUS Supplier Price Index for all Distilled Spirits has remained unchanged in the fourth quarter of 2019 compared to the third quarter of 2019. Total Domestic Spirits prices increased 0.1%, and Total Imported Spirits prices did not change. Domestic Cordials & Liqueurs showed the largest increase at 0.9%.

Compared with the fourth quarter of 2018, the SPI for the fourth quarter of 2019 was up 0.2%. Prices for Domestic Spirits were up 0.1% and prices for Imported Spirits were up 0.3%. Total Whiskey increased 0.1% overall, while the Non-Whiskey index was up 0.3%. The largest increases over last year's fourth quarter were posted by Domestic Cordials & Liqueurs and Irish Whiskey with 1.3% and 0.8%, respectively. Meanwhile, Domestic Brandy & Cognac prices were down 0.5%.
