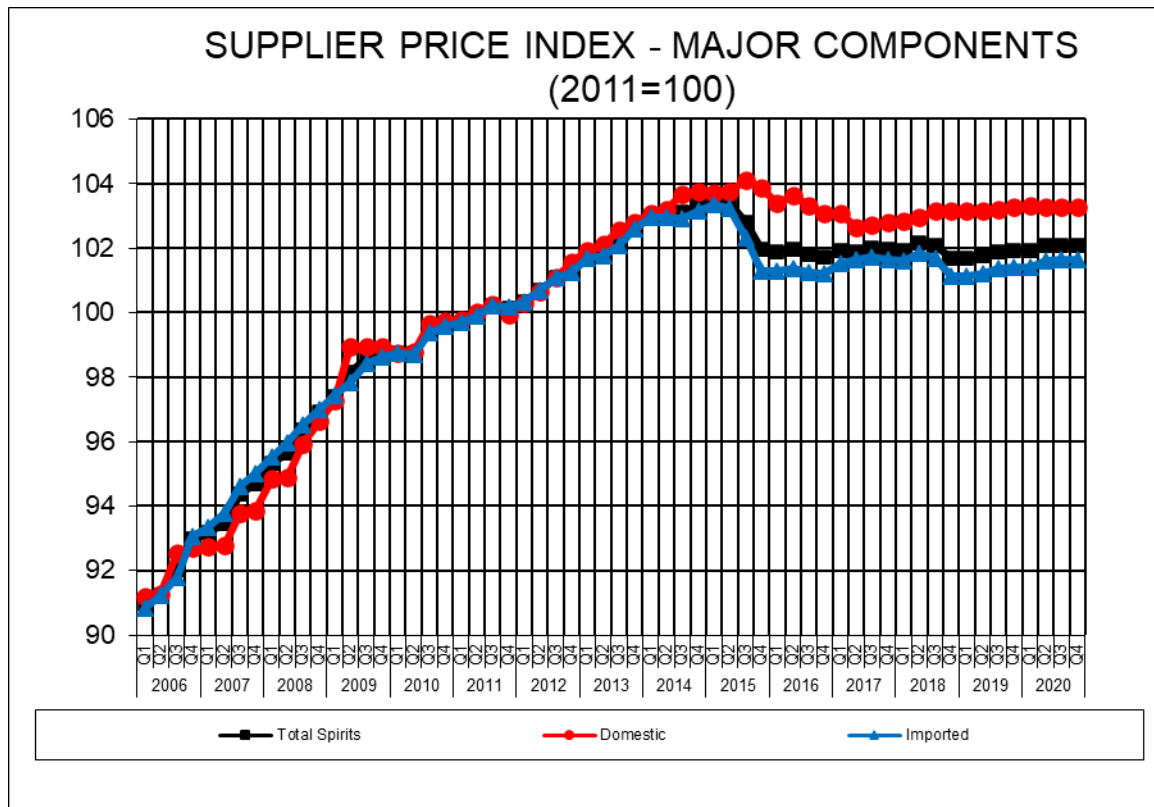


SUPPLIER PRICE INDEX

FOURTH QUARTER 2020

The DISCUS Supplier Price Index for all Distilled Spirits has remained unchanged in the fourth quarter of 2019 compared to the third quarter of 2019. Tequila prices showed the largest increase at 0.3%.

Compared with the fourth quarter of 2019, the SPI for the fourth quarter of 2019 was up 0.2%. Prices for Domestic Spirits were up 0.1% and prices for Imported Spirits were up 0.2%. Total Whiskey increased 0.6% overall, while the Non-Whiskey index remained unchanged. The largest increases over last year's fourth quarter were posted by Scotch Malt Whiskey and Irish Whiskey with 7.4% and 1.7%, respectively.
